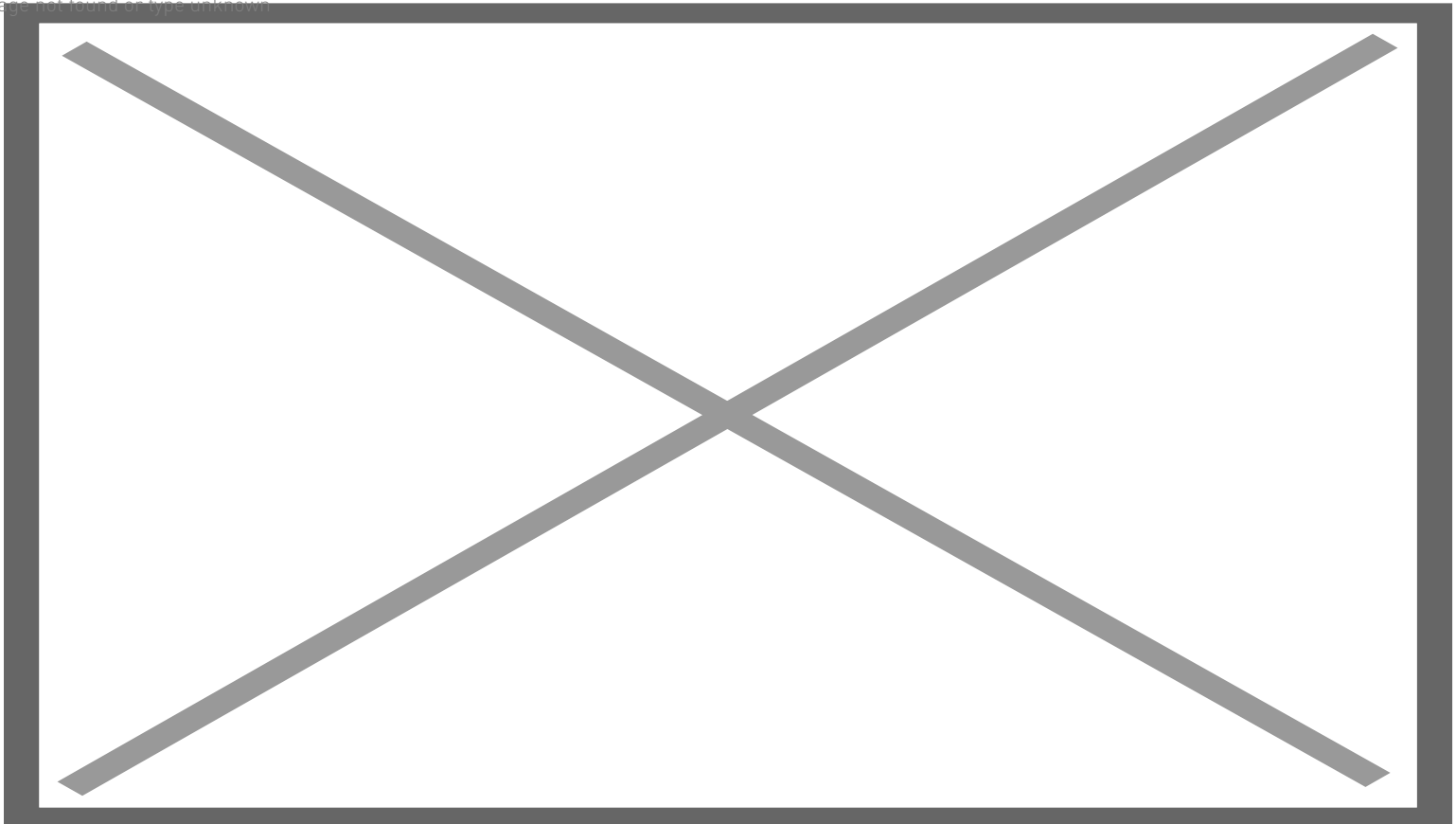

Fondée en 1991, cette entreprise de fabrication de métaux à vendre est l'un des principaux producteurs de profilés en aluminium en Turquie. L'entreprise métallurgique a atterri sur une superficie totale de plus de 40.000m<sup>2</sup> près d'Istanbul. L'entreprise dispose de 3 lignes d'extrusion à des échelles de 2750, 1850 et 1540 tonnes. La presse d'extrusion 2750 de la société est l'une des plus grandes presses automatiques de l'industrie, capable de produire des profilés trempés de 310 mm de large et de 13,4 mètres de long.

Avec plus de 20.000 tonnes de capacité de production, maintenant l'entreprise s'engage dans la production de profils standard, de profils sigma, de profils de meubles, de profils led/refroidissement, de profils à énergie solaire.

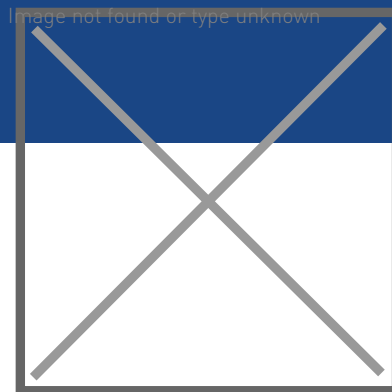
